## **UPDATES ON SINGLE-ENTRY VISA**

We are glad to share that citizens of 48 countries may obtain single-entry visa of the following categories without invitation from host party:

- A3 service;
- B1, B3 business;
- B10 private;
- B12 tourist.

To obtain a visa, you only need to contact the consulate of Kazakhstan in the country of citizenship or permanent residence, submit an application and pay the consular fees for acquiring a visa.

Australia, Austria, Belgium, Bulgaria, Brazil, United Kingdom, Hungary, Germany, Greece, Denmark, Israel, Jordan, Ireland, Iceland, Spain, Italy, Canada, Qatar, Cyprus, Latvia, Lithuania, Liechtenstein, Luxembourg, Malaysia, Malta, Monaco, Netherlands, New Zealand, Norway, UAE, Oman, Poland, Portugal, Romania, Saudi Arabia, Singapore, Slovakia, Slovenia, USA, Finland, France, Croatia, Czech Republic, Switzerland, Sweden, Estonia, South Korea, Japan.

Please note that entry permit from Interdepartmental Commission may be additionally required but not for citizens of states, with whom Kazakhstan resumed direct flights.



### **UPDATES ON BORDER CROSSING PROCEDURE**



Dear friends, please note that it is allowed to cross the border without entry permit from State Commission to the following foreign citizens:

·Foreign citizens who are relatives to the citizens of the Republic of Kazakhstan, with the verification of family relationships;

·Foreign citizens who are family members of citizens of the Republic of Kazakhstan, that are coming for taking care for seriously sick/ ill patients, accompanying spouses and under age children as well as to those who are coming to the funeral.
