At the moment, direct flights are resumed with the following 18 countries:

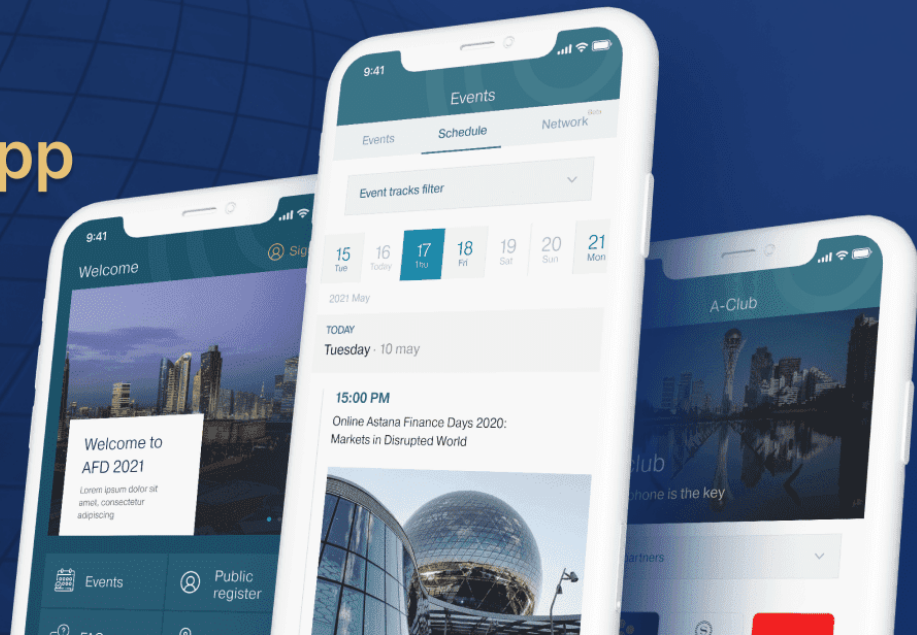

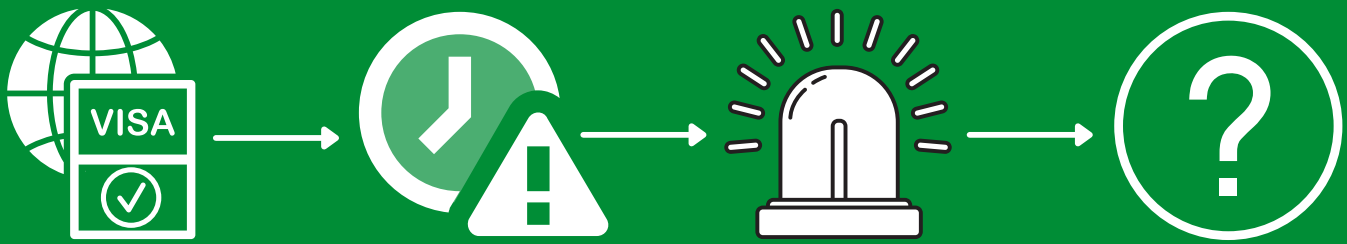
Please find important information on violation by a foreign citizen or stateless person of the legislation of the Republic of Kazakhstan in the field of migration of population.

2. Non-compliance with the rules of transit through the territory of the Republic of Kazakhstan, leads to a fine of 15 MCI or administrative expulsion from the Republic of Kazakhstan.

3. Not timely departure from the Republic of Kazakhstan after the expiration of the period established by the legislation of the Republic of Kazakhstan:

- within 3 days is subject to warning;
- more than 3 days before the expiration of 5 days, will lead to a fine in the amount of 10 MCI;
- more than 5 days before the expiration of 10 days, will lead to a fine of 15 MCI;





4. Evasion of departure within a period exceeding 10 days after the expiration of the period established by the legislation, will lead to a fine in the amount of 25 MCI or administrative expulsion from the Republic of Kazakhstan

5. Inconsistency of the activities carried out with the goals specified in the visa, or employment in the Republic of Kazakhstan without obtaining a certificate of compliance of qualifications for self-employment issued by the local executive body, or work permit, will lead to a fine in the amount of 25 MCI, administrative arrest for up to 10 days or administrative expulsion from the Republic of Kazakhstan

6. Actions, or failures to act, covered by paragraph 3 of this article, that are committed repeatedly within the year following the imposition of an administrative penalty will lead to a fine in the amount of 15 MCI or administrative expulsion from the Republic of Kazakhstan

7. Acts referred to paragraphs 2,4 and 4 of this article committed repeatedly within a year following the imposition of an administrative penalty will lead to administrative arrest up to 15 days with administrative expulsion from the Republic of Kazakhstan.
