Here some updates on sanitary norms on entry to Kazakhstan. Such as, vaccination passports of the following countries are recognised in Kazakhstan:

Georgia
Thailand

Hungary
Kyrgyzstan

Mongolia
Moldova

By these means, that citizens of mentioned states may travel to Kazakhstan with vaccination passports, issued in the above-mentioned countries, without need of presenting PCR certificate.

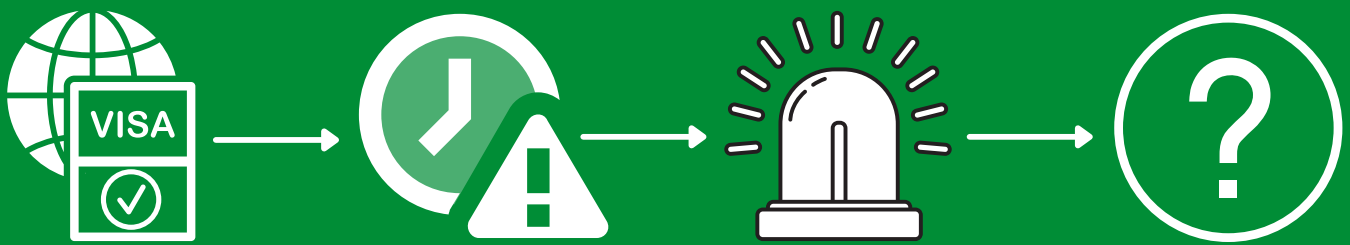
Please find important information on fines and sanctions, that presumed for violations of visa and migration regime:

In accordance with Article 518 of the Code of Administrative Offences, the inviting party will be charged for the following:

- Untimely notification of the Migration Authority on arrival of a foreign citizen to the Republic of Kazakhstan;
- Failure to take measures to prepare documents for the eligibility to stay (visa, permit, temporary permit for stay);
- Untimely departure of a foreign citizen outside the country.

Violation leads to the fines:

- 10 MCI (29,170 tenge) to 75 MCI (218,775 tenge), depending on the business entity;
- Repeated violation within 12 consecutive months will lead to a fine of up to 100 MCI (291,700 tenge). In this regard, the host party / legal entity will not be able to process visa invitations within 1 year.

What to Do?

Do you know what to do if your current visa is expiring soon and you need to leave the country, however there are some force majeure circumstances that are generally intended to include occurrences beyond reasonable control?

1. Please, urgently contact the Migration Office, or if you are an AIFC Participant, please, contact us, the AIFC Expat Centre.
2. You have a good chance to get a short-stay visa extension if something unexpected has occurred all of the sudden. You will be granted with an extension of a few weeks, or until the situation changes.

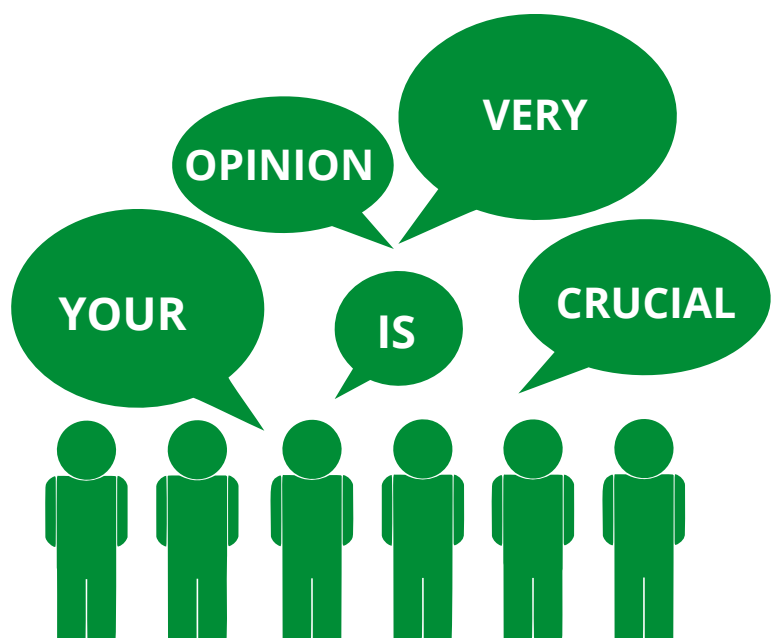
*Force majeure - you can not immediately return to your home country because of serious events which have occurred there during your stay in the Republic of Kazakhstan: medical reasons, natural disasters, extreme weather conditions, major political turmoil, etc.
