#### GUIDELINES FOR REGISTRATION OF LEGAL ADVISERS: HOW TO APPLY

This note was prepared to provide guidance for Legal Advisers to register in the Roll of Registered Legal Advisers (the Roll). Entry on the Roll is governed by AIFC Legal Services Regulations 2022 and these Rules.

## **HOW TO APPLY**

# **Submission of application**

To apply, the application form as set out in Schedule 1 and supporting documents shall be sent to the Office of the AIFC Legal Services Board at OfficeLSB@aifc.kz.

The admission date is determined by the AIFC Legal Services Board once each month. You should send your application at least 5 business days before the date on which you are expecting to be admitted.

# The List of supporting documents required for registration:

- Copy of current Practicing Certificate or letter of Good Standing from Recognised Professional Bodies as determined by decision of the AIFC Legal Services Board No. 1 dated 31 May 2022 (for Kazakhstani lawyers, in the absence of a practising certificate, present a copy of the bachelor law degree)
- 2. Copy of national ID/passport;
- 3. Digital photo;
- 4. Copy of a valid indemnity insurance policy (all practitioners, including those outside Kazakhstan).

# Minimum terms and conditions for professional indemnity insurance

Section 18 (b) of the AIFC Legal Services Regulations requires a Legal Adviser applying for registration to the AIFC Legal Services Board to demonstrate to the satisfaction of the Board that he or she has obtained or is able to rely on adequate and appropriate professional indemnity insurance.

Professional indemnity insurance as required under section 18 (b) of the AIFC Legal Services Regulations shall indemnify a Legal Adviser against civil liability to the extent that it arises from private legal practice in the AIFC.

The minimum cover of professional indemnity insurance shall be at least in the amount equal to 1000 times the monthly calculation index established annually by the Law of the Republic of Kazakhstan on the Republican Budget for the corresponding year. For each subsequent year, the minimum cover of professional indemnity insurance might be reconsidered by the AIFC Legal Services Board.

Professional indemnity insurance may be obtained from insurance companies of the Republic of Kazakhstan or international insurance companies, provided that such insurance covers the territory of the Republic of Kazakhstan.

### **Fees for Registration**

Subject to section 5 (c) of the AIFC Legal Services Regulations, no fee will be charged for registration until 3 May 2023.

#### Result of application

On the day you are admitted, the AIFC Legal Services Board will issue your Certificate of Registration and include your name on the Roll of Registered Legal Advisers, which is available on the official website of the AIFC Authority.

#### Removal on a Registered Legal Adviser's initiative

If a Registered Legal Adviser wishes to be removed from the Roll of Registered Legal Advisers they should send a signed letter requesting this addressed to the Office of AIFC Legal Services Board by email to OfficeLSB@aifc.kz. If a Registered Legal Adviser wishes to suspend their registration in the Roll of Registered Legal Advisers, they should send a letter requesting this addressed to the Office of the AIFC Legal Services Board by email to OfficeLSB@aifc.kz. It should be noted that the Registered Legal Adviser may renew their registration and be reinstated to the Roll of Registered Legal Advisers by sending

a letter to OfficeLSB@aifc.kz requesting restoration of their registration, along with the respective payment of the annual fee and evidence of the required liability insurance.

# **Sanctions for Contravention**

If the AIFC Legal Services Board considers that a Registered Legal Adviser has Contravened the AIFC Legal Services Regulations and Rules of the AIFC Legal Services Board, the Board may take disciplinary actions as set out in section 10 (c) of the AIFC Legal Services Regulations, including a suspension of the Registered Legal Adviser's registration with the Board, or removal from the Roll of Registered Legal Advisers.

A Registered Legal Adviser Contravenes the AIFC Legal Services Regulations and Rules of the AIFC Legal Services Board, if the Registered Legal Adviser:

- (a) does something that the Registered Legal Adviser is prohibited from doing by or under the AIFC Legal Services Regulations and Rules of the AIFC Legal Services Board; or
- (b) does not do something that the Person is required or directed to do (however described) by or under the AIFC Legal Services Regulations and the Rules of the AIFC Legal Services Board.

## Processing of your personal data

  data on our behalf who are contractually obligated to keep your personal data confidential and
  subject to appropriate safeguards; and
