2. INTERPRETATION

<b>Accepting Deposits</b>	The Regulated Activity as defined in paragraph 17 of Schedule 1 of GEN.
<b>Accredited Investor</b>	(In MAR) means: (i) any natural person who acquires or intends to acquire Securities for a total consideration of at least USD100,000 (or an equivalent amount in another currency) per Person for each separate offer; or (ii) an Authorised Person; or (iii) a Body Corporate.
<b>Acting as the Trustee of a Fund</b>	The Regulated Activity as defined in paragraph 9 of Schedule 1 of GEN.
<b>Admission to Clearing Rules</b>	(In AMI) rules prepared by an Authorised Clearing House in accordance with AMI 4.1.
<b>Admission to Trading Rules</b>	(In AMI) rules prepared by an Authorised Investment Exchange in accordance with AMI 3.2.
<b>Advising on a Credit Facility</b>	The Regulated Activity as defined in paragraph 19 of Schedule 1 of GEN.
<b>Advising on Investments</b>	The Regulated Activity as defined in paragraph 10 of Schedule 1 of GEN.
<b>Advisor</b>	In relation to a Fund, a Person who is retained by the Fund, its Eligible Custodian, a Person providing oversight or its Fund Manager under a commercial arrangement which is not a contract of service: (a) to supply any of them with the advice in relation to the Fund as to the merits of investment opportunities or information relevant to the making of judgments about the merits of investment opportunities; or (b) to exercise for any of the functions concerning the management of the Fund Property.
<b>Affiliate</b>	In relation to a Firm, any entity of which the Firm holds directly or indirectly or controls 10% or more but less than a majority of the voting power.
<b>AFSA</b>	Astana Financial Services Authority
<b>AIFC</b>	Astana International Financial Centre
<b>AIFC Court</b>	The court specified under Article 13 of the Constitutional Statute.
<b>AIFC Operation</b>	The PRU Investment Business of an Externally Regulated PRU Investment Firm that is (a) carried on through an establishment in the AIFC or (b) carried on through an establishment outside the AIFC but with customers who are resident in the AIFC.
<b>AIFC-Incorporated Insurer</b>	An Insurer that is incorporated as a legal entity under the laws of the AIFC
<b>AIFC-Incorporated Takaful Operator</b>	A Takaful Operator that is incorporated as a legal entity under the laws of the AIFC
<b>AIFC Legal Services Board</b>	A designated body for the registration and regulation of Legal Advisers to maintain the safety and soundness of the legal services market in the AIFC.



<b>Algorithmic stablecoin</b>	A Digital Asset which uses, or purports to use, an algorithm to increase or decrease the supply of Digital Assets in order to stabilise its price or reduce volatility in its price
<b>AMI</b>	The Authorised Market Institution Rules.
<b>AML</b>	The Anti-Money Laundering, Counter-Terrorist Financing and Sanctions Rules.
<b>AML Return</b>	A report in a prescribed format to be filed on an annual basis as described in AML 13.7.
<b>Ancillary Service</b>	An activity specified in Schedule 2 of GEN.
<b>Ancillary Service Provider</b>	A Centre Participant which has been licensed by the AFSA to carry on one or more Ancillary Services.
<b>Annual Operating Expenditure</b>	The amount determined as such in accordance with PRU(INV) 4.4.
<b>Approved Actuary</b>	The Approved Individual performing the role identified at PINS 2.2.5 (Approved Actuary) The Approved Individual performing the role identified at TRR 2.4.5 (Approved Actuary).
<b>Approved ECAI</b>	An External Credit Assessment Institution in respect of which the AFSA has given approval for its ratings to be relied on by PRU Investment Firms in relation to PRU(INV) 4.
<b>Approved Individual</b>	An individual who is (1) approved by the AFSA to carry out a Controlled Function; and (2) approved by the AFSA to be appointed by a DNFBP and Registered Auditor to carry out the MLRO function.
<b>Arranging a Credit Facility</b>	The Regulated Activity as defined in paragraph 20 of Schedule 1 of GEN.
<b>Arranging Custody</b>	The Regulated Activity as defined in paragraph 6 of Schedule 1 of GEN.
<b>Arranging Deals in Investments</b>	The Regulated Activity as defined in paragraph 11 of Schedule 1 of GEN.
<b>Assessed Professional Client</b>	Has the meaning given in COB 2.5.1 and 2.5.6.
<b>Asset Risk Component</b>	The capital component identified in paragraph 4.1 of PINS Schedule 5 (Calculation of Prescribed Capital Requirement) The capital component identified in paragraph 4.1 of TRR Schedule 5 (Calculation of Prescribed Capital Requirement)
<b>Associate</b>	In respect of a Person 'A', any Person, including an affiliated company which is: (a) an Undertaking in the same Group as A; or (b) any other person whose business or domestic relationship with A or his Associate might reasonably be expected to give rise to a community of interest between them which may involve a conflict of interest in dealings with third parties.



<b>Associated Party</b>	<p>PINS: (a) a holding company, subsidiary or related company of an AIFC-Incorporated Insurer, (b) a subsidiary or related company of a holding company of an AIFC-Incorporated Insurer, (c) a holding company of a subsidiary of an AIFC-Incorporated Insurer, or (d) a company that, alone or with associates, is entitled to exercise, or control the exercise of, more than 50% of the voting power in the general meeting of an AIFC-Incorporated Insurer.</p> <p>TRR: (a) a holding company, subsidiary or related company of an AIFC-Incorporated Takaful Operator, (b) a subsidiary or related company of a holding company of an AIFC-Incorporated Takaful Operator, (c) a holding company of a subsidiary of an AIFC-Incorporated Takaful Operator, or (d) a company that, alone or with associates, is entitled to exercise, or control the exercise of, more than 50% of the voting power in the general meeting of an AIFC-Incorporated Takaful Operator.</p>
<b>AT1 Capital</b>	<p>Additional Tier 1 Capital, as defined in BBR 4.16</p> <p>In (RAR) rules mean Additional Tier 1 Capital.</p>
<b>Audit Personnel</b>	<p>An individual:</p> <p>(a) who is employed or appointed by an Auditor in connection with the Auditor's business in the AIFC, whether under a contract of service or for services or otherwise; or</p> <p>(b) whose services provided in the AIFC, under an arrangement between the Auditor and a third party, are placed at the disposal and under the control of the Auditor.</p>
<b>Audit Principal</b>	<p>A natural person who is appointed by an Auditor under AUD 2.1.3(d).</p>
<b>Auditor</b>	<p>(a) in relation to an Authorised Person which is incorporated in the AIFC has the meaning given in AUD 1.</p> <p>(b) in relation to an Authorised Person which is a Recognised Company or Recognised Partnership – an auditor of that Authorised Person;</p> <p>(c) in relation to a Reporting Entity – an auditor.</p>
<b>Authorised Clearing House</b>	<p>A Centre Participant which has been licensed by the AFSA to carry on the Market Activity of Operating a Clearing House.</p>
<b>Authorised Crowdfunding Platform</b>	<p>A Centre Participant which has been licensed by the AFSA to carry on the Market Activity of Operating a Loan Crowdfunding Platform and/or the Market Activity of Operating an Investment Crowdfunding Platform.</p>
<b>Authorised Firm</b>	<p>A Centre Participant which has been licensed by the AFSA to carry on one or more Regulated Activities.</p>
<b>Authorised Investment Exchange</b>	<p>A Centre Participant which has been licensed by the AFSA to carry on the Market Activity of Operating an Investment Exchange.</p>
<b>Authorised Market Institution</b>	<p>A Centre Participant which has been licensed by the AFSA to carry on one or more Market Activities.</p>
<b>Authorised Person</b>	<p>Either an Authorised Firm or an Authorised Market Institution</p>
<b>Authorised Promoter</b>	<p>Has the meaning given in COB 3.3.1.</p>
<b>Bail-In Tool</b>	<p>The Resolution Tool referred to in section 147(1)(i) and 149 of the FSFR.</p>



<b>Bank</b>	A Regulated Financial Institution that is authorised to accept deposits or Open and Operate Bank Accounts or both, as defined in BBR 1.5.
<b>Bank Account</b>	A Correspondent Account, Current Account, or Savings Account.
<b>Banking Book</b>	Includes all on and off-balance sheet positions, exposures, items, which are not included in the Trading Book.
<b>Banking Business Firm</b>	Has the meaning given in AIFC BBR rule 1.4
<b>Base Capital Requirement</b>	The meaning given in PRU(INV) 3.3(3). For Banking Business Firms has the meaning given in BBR 4.10.
<b>Basel Requirements</b>	The rules and guidance from time to time published by the Basel Committee on Banking Supervision.
<b>BBR</b>	AIFC Banking Business Prudential Rules
<b>Beneficial owner</b>	<p>(1) Beneficial owner, in relation to a customer, is:</p> <p>(a) for an account – a natural person who ultimately owns, or exercises effective control over the account;</p> <p>(b) for a transaction – a natural person on whose behalf or for whose benefit the transaction is being conducted;</p> <p>(c) for a legal person or arrangement – a natural person who ultimately owns or exercises effective control over the legal person or arrangement.</p> <p>(2) Without limiting subrule (1) (a), a beneficial owner for an account includes any natural person on whose instructions the signatories of an account, or any intermediaries instructing such signatories, are acting (either temporarily or permanently).</p> <p>(3) Without limiting (1) (c), the beneficial owner for:</p> <p>(a) a legal person includes:</p> <ul style="list-style-type: none"> <li>(i) a natural person who, directly or indirectly, owns or controls at least 25% of the shares, participation interest or voting rights of the legal person; or</li> <li>(ii) a natural person who, directly or indirectly, otherwise exercises control over the legal person’s management;</li> </ul> <p>(b) a legal arrangement that administers and distributes funds (such as a trust) includes:</p> <ul style="list-style-type: none"> <li>(i) where the beneficiaries and their distributions have already been determined - a natural person who is to receive at least 25% of the funds of the arrangement;</li> <li>(ii) where the beneficiaries or their distributions have not already been determined – a natural person who is part of the class of natural persons for whose benefit the arrangement is established or operated and who could receive at least 25% of the funds of the arrangement; or</li> <li>(iii) where a natural person, directly or indirectly, exercises control over at least 25% (by value) of the property of the arrangement.</li> </ul>
<b>Board</b>	In reference to a corporation, the board of directors of the corporation.



<b>Body Corporate</b>	Any body corporate, including a limited liability partnership and a body corporate constituted under the law of a country or territory outside the AIFC.
<b>Borrower</b>	A Person who seeks and/or receives funding in the form of one or more loans under an agreement with a lender via the sale of a Debenture which may be facilitated via a Loan Crowdfunding Platform as set out in paragraph 4 of Schedule 4 of AIFC General Rules.
<b>BPG</b>	AIFC Banking Business Prudential Guideline
<b>Branch</b>	A Centre Participant which is incorporated pursuant to the law of a jurisdiction other than the AIFC.
<b>Broker Dealer</b>	Has the meaning given in BBR 1.6
<b>Business Reorganisation Plan</b>	A plan drawn up in accordance with RAR 4.4.7.
<b>Business Rules</b>	(In AMI) rules established and maintained by an Authorised Market Institution in accordance with AMI 2.5.1.  (In MOTF) rules established and maintained by a MTF Operator or an OTF Operator in accordance with MOTF 6.1.
<b>Capital Conservation Buffer</b>	Has the meaning given in BBR 4.31
<b>Capital Floor</b>	The minimum paid up share capital, or equivalent in any currency acceptable to the AFSA, which must be maintained by an AIFC-Incorporated Insurer pursuant to paragraph 1.1 (The Capital Floor) of PINS Schedule 4 (Calculation of Minimum Capital Requirement (MCR)).  The minimum paid up share capital, or equivalent in any currency acceptable to the AFSA, which must be maintained by an AIFC-Incorporated Takaful Operator pursuant to paragraph 1.1 (The Capital Floor) of TRR Schedule 4 (Calculation of Minimum Capital Requirement (MCR)).
<b>Capital Resources</b>	In PRU(INV) has the meaning given in PRU(INV) 3.2. In PRU(INT) has the meaning given in PRU(INT) 3.1(1).
<b>Captive Insurance Business</b>	The business of Effecting or Carrying out Contracts of Insurance only for the business or operations of the Group to which the Captive Insurer belongs.
<b>Captive Insurer</b>	An Authorised Firm with a Licence to carry on Insurance Business only for the business or operations of the Group to which it belongs.
<b>Captive Takaful Business</b>	The business of Effecting or Carrying out Takaful Contracts only for the business or operations of the Group to which the Captive Takaful Operator belongs.
<b>Captive Takaful Operator</b>	An Authorised Firm with a Licence to carry on Takaful Business only for the business or operations of the Group to which it belongs.
<b>CDD</b>	Customer Due Diligence, as described generally in AML 6
<b>Central Counterparty</b>	A legal person that interposes itself between the counterparties to the contracts traded on one or more financial markets, becoming the buyer to every seller and the seller to every buyer.



<b>Central Bank Digital Currency</b>	A digital currency issued by any government, government agency, central bank, or another monetary authority
<b>Central Securities Depository</b>	A Person who holds Securities or Units in a Listed Fund in uncertificated (dematerialised) form so as to act as a repository of ownership entitlements to such Investments to enable book entry transfer of such Investments for the purposes of settlement of transactions.
<b>Centralised Digital Asset</b>	Digital Asset issued by a single or several administrating authorities that establish the rules for its use, maintain a central payment ledger, and have authority to redeem the Currency (withdraw it from circulation).
<b>Centre Bodies</b>	The bodies identified in Article 9 of the Constitutional Statute.
<b>Centre Participant</b>	As defined in Article 1(5) of the Constitutional Law: “legal entities incorporated pursuant to the acting law of the Centre, and other legal entities accredited by the Centre”
<b>CET1 Capital</b>	(In RAR) rules means Common Equity Tier 1 Capital , described in BBR.
<b>Certificate</b>	An instrument: (a) which confers on the holder contractual or property rights to or in respect of a Share, Debenture or Warrant held by a Person; and (b) the transfer of which may be effected by the holder without the consent of that other Person; but excludes rights under an Option.
<b>CIS</b>	The Collective Investment Scheme Rules.
<b>Client</b>	A Person to whom a Centre Participant provides, intends to provide or has provided a service in the course of carrying on a Regulated Activity, Market Activity or Ancillary Service.
<b>Client Account</b>	In relation to Client Investments or Client Digital Assets is an account which: (a) is held with a Third Party Agent or by an Authorised Firm which is authorised under its Licence to Provide Custody; (b) is established to hold Client Assets; (c) when held by a Third Party Agent, is maintained in the name of: (i) if a Domestic Firm, the Authorised Firm; or (ii) if not a Domestic Firm, a Nominee Company controlled by the Authorised Firm; and (d) includes the words ‘Client Account’ in its title.
<b>Client Assets</b>	Client Money and Client Investments
<b>Client Investment</b>	An investment as defined in COB 8.3.1.
<b>Client Investment Account</b>	An account as defined in COB 8.3.4.
<b>Client Investments Auditor's Report</b>	The report specified in COB 8.3.14.
<b>Client Investments Rule</b>	The Rules contained in COB 8.3.
<b>Client Money</b>	In COB 8, has the meaning given in Rule 8.2.1;

<b>Client Money Account</b>	Has the meaning given in COB 8.2.4
<b>Client Money Auditor's Report</b>	The report specified in COB 8.2.19.
<b>Client Money Distribution Rules</b>	In COB 8, the Rules contained in COB 8.2.16; In COB 11, the Rules contained in COB 11.8.14.
<b>Client Money Rules</b>	The Rules contained in COB 8.2.
<b>COB</b>	The Conduct of Business Rules.
<b>Code of Ethics for Professional Accountants</b>	The code of ethics for accountants issued by the International Ethics Standard Board for Accountants (IESBA) of IFAC.
<b>Cold Digital wallet</b>	A Digital wallet that is stored in a platform (device) that is not connected to the Internet.
<b>Collateral</b>	An Investment which belongs to a Client has been paid for in full by the Client and which is held or controlled by the Authorised Firm under the terms of a deposit, pledge, charge or other security arrangement.
<b>Collective Investment Scheme</b>	As defined in section 92 of the Framework Regulations, which is, in summary, any arrangements with respect to property of any description, including money, the purpose or effect of which is to enable Persons taking part in the arrangements (whether by becoming owners of the property or any part of it or otherwise) to participate in or receive profits or income arising from the acquisition, holding, management or disposal of the property or sums paid out of such profits or income.
<b>Commercial Captive Finance</b>	As an activity of a Credit Provider, means providing finance to a Professional Client or a Market Counterparty to enable them to lease or purchase (through finance lease, operating lease, hire-purchase or a similar form) an asset (usually immoveable properties, machinery, vehicles and equipment) from the Credit Provider's parent entity or from a member of the parent entity's group.
<b>Commitment Period</b>	The period specified by an Authorised Crowdfunding Platform in which lenders or Investors may commit to lending to a particular Borrower or investing with a particular Issuer.



<b>Commodities Risk Capital Requirement</b>	A component of Market Risk Capital Requirement and calculated in accordance with BBR 6.5 and chapter 6 of BPG.
<b>Commodity</b>	Any goods of a fungible nature that are capable of being delivered, including but not limited to metals and their ores and alloys, agricultural products, energy, such as gas and electricity, and Environmental Instruments.
<b>Commodity Derivative</b>	A Derivative in respect of a Commodity.
<b>Commodity stablecoin</b>	A Digital Asset whose value purports to be determined by reference to a commodity (e.g., gold, oil).
<b>Company service provider</b>	<p>A Company service provider is a Person, not captured by (a) to (e) of the definition of DNFBP that, by way of business, provides any of the following services to a customer:</p> <p>(a) acting as an agent of legal persons to form a company;</p> <p>(b) acting as, or arranging for another Person to act as, a director or secretary of a company, a partner of a partnership, or a similar position in relation to other legal persons;</p> <p>(c) providing a registered office, business address, or accommodation, correspondence or administrative address for a company, a partnership, or any other legal person or arrangement; or</p> <p>(d) acting as, or arranging for another Person to act as, a nominee shareholder for another Person, including through acting on trust for discretionary purposes.</p>
<b>Compliance Officer</b>	The individual performing the Controlled Function identified in GEN 2.2.5.
<b>Connected Person</b>	<p>In relation to a Person (A), a Person which has or at any relevant time had the following relationship to A:</p> <p>(a) a member of A's Group;</p> <p>(b) a Controller of A;</p> <p>(c) a member of a partnership of which A is a member;</p> <p>(d) an Employee or former Employee of A;</p> <p>(e) if A is a Body Corporate:</p> <p>(i) an officer or manager of A or of a parent of A;</p> <p>(ii) an agent of A or of a parent of A;</p> <p>(f) if A is a Partnership is or has been a member, manager or agent of A; or</p> <p>(g) if A is an unincorporated association of persons which is not a Partnership, is or has been an officer, manager or agent of A.</p>
<b>Consolidated Return</b>	A Consolidated prudential return means a prudential return which reflects the accounts, statements and reports of a Bank consolidated with those of the other members of its Financial Group
<b>Constitution</b>	<p>In relation to a Fund:</p> <p>(a) which is in the form of a Body Corporate, the instrument of incorporation;</p> <p>(b) which is in the form of a Trust, the trust deed;</p>



	<p>(c) which is in the form of a Partnership, the partnership deed; or</p> <p>(d) adopting a form other than one specified in (a) to (c), any instrument creating the legal form of the Fund to which the Fund Manager is a party setting out provisions relating to any aspect of the operation or management of the Fund.</p>
<b>Contingency Funding Plan</b>	Has the meaning given in BBR 9.10
<b>Contingent Liability Transaction</b>	A Derivative under the terms of which the Client will or may be liable to make further payments (other than charges, and whether or not secured by margin) when the transaction falls to be completed or upon the earlier closing out of his position.
<b>Contract for Differences</b>	<p>(1) Subject to sub-paragraph (2), rights under—</p> <p>(a) a contract for differences; or</p> <p>(b) any other contract the purpose or pretended purpose of which is to secure a profit or avoid a loss by reference to fluctuations in—</p> <p>(i) the value or price of property of any description; or</p> <p>(ii) an index or other factor designated for that purpose in the contract.</p> <p>(2) There are excluded from sub-paragraph (1) —</p> <p>(a) rights under a contract if the parties intend that the profit is to be secured or the loss is to be avoided by one or more of the parties taking delivery of any property to which the contract relates;</p> <p>(b) rights under a contract under which money is received by way of deposit on terms that any interest or other return to be paid on the sum deposited will be calculated by reference to fluctuations in an index or other factor;</p> <p>(c) rights under a Contract of Insurance.</p>
<b>Contract of Insurance</b>	Any contract of insurance or contract of reinsurance.
<b>Contract of Insurance</b>	Any enforceable contract under which a 'provider' undertakes: (1) in consideration of one or more payments; (2) to pay money or provide a corresponding benefit (including in some cases services to be paid for by the provider) to a 'recipient'; (3) in response to a defined event the occurrence of which is uncertain (either as to when it will occur or as to whether it will occur at all) and adverse to the interests of the recipient
<b>Contract of Reinsurance</b>	A Contract of Insurance covering all or part of a risk to which a Person is exposed under a Contract of Insurance
<b>Contravention</b>	The conduct identified in section 119 of FSFR.
<b>Control</b>	<p>In relation to a Family Business or Family Entity, the exercise of at least 75 per cent of voting control or other direct or indirect control over the affairs of that Family Business or Family Entity by:</p> <p>(a) one or more members of a Single Family;</p> <p>(b) one or more Family Fiduciary Structures;</p> <p>(c) one or more Family Entities; or</p> <p>(d) a combinations of any of the above.</p>



<b>Controlled Function</b>	A function of an Authorised Person that may only be carried out by an Approved Individual.
<b>Controller</b>	A Person who, either alone or with any Associate:  (a) holds 10% or more of the shares in either the Authorised Person or a Holding Company of that Authorised Person; or  (b) is entitled to exercise, or controls the exercise of, 10% or more of the voting rights in either the Authorised Person or a Holding Company of that Authorised Person; or  (c) is able to exercise significant influence over the management of the Authorised Person as a result of holding shares or being able to exercise voting rights in the Authorised Person or a Holding Company of that Authorised Person or having a current exercisable right to acquire such shares or voting rights.

<b>Savings Account</b>	An account with a Bank held in the name of a Client through which the Client can place and withdraw Deposits.
<b>SDD</b>	Simplified Due Diligence, as described in AML 8.1.1.
<b>Securities Note</b>	In relation to a Prospectus structured as multiple documents, the document referred to in MAR 1.3.1(a)(iii).
<b>Securities Settlement System</b>	A system operated by a Person which enables Investments held in accounts to be transferred and settled by book entry according to a set of laws and predetermined multilateral rules to provide legal certainty.
<b>Security</b>	1. A Security is: (a) a Share; (b) a Debenture; (c) a Warrant; (d) a Certificate; or (e) a Structured Product. 2. Only for the purposes of article 6 of the Constitutional Statute, a Security includes a Unit or a Security Token.





<b>Security Token</b>	A digital representation of a Security or Unit, that is issued, transferred and stored using DLT or other similar technology approved by the AFSA.

In this definition, <b>physical presence</b> in a jurisdiction is a presence involving meaningful decision-making and management and not merely the presence of a local agent or low level staff.
<b>Single Family</b>	An individual or group of individuals that are the lineal descendants (including minors, descendants by adoption (that is, stepchildren, adopted children, foster children, children adopted by legal guardianship), and illegitimate children) of a common ancestor (who is no more than 10 generations removed from the youngest generation of family members) or their spouses (including widows or widowers, whether or not remarried).

<b>Smart-Contract</b>	A computer code that represents a contract, and that executes and enforces the terms of such contract on an automated basis, without the need for intermediation by any person.
<b>Solo Prudential Return</b>	A prudential return is referred to as a Solo Prudential Return if it reflects the individual Bank's accounts, statements and reports.
<b>Solvency Reference Date</b>	The date at which an Insurer's compliance with the requirements of PINS 5 (Capital adequacy requirements) is assessed.  The date at which a Takaful Operator's compliance with the requirements of TRR 5 is assessed.
<b>Source(s) of Funds</b>	The origin of the customer's funds which relate to a transaction or service and includes how such funds are connected to a customer's source of wealth.
<b>Source(s) of Wealth</b>	How the customer's global wealth or net worth is or was acquired or accumulated.
<b>STR</b>	Suspicious Transaction Report. A report in a prescribed format regarding suspicious activity or suspicious transactions made to the FIU.

<p><b>Takaful Contract</b></p>	<p>Any Contract of Insurance which is Shari’ah-compliant and is either a Family Takaful Contract or a General Takaful Contract</p>
<p><b>Takaful Fund</b></p>	<p>Has the meaning given in TRR 1.1.5 (2)</p>
<p><b>Takaful Liabilities</b></p>	<p>Liabilities of a Takaful Operator arising out of its General Takaful Business and Family Takaful Business.</p>
<p><b>Takaful Operator</b></p>	<p>Has the meaning given in TRR 1.1.5 (1)</p>

<b>Takeover Offer</b>	A public offer (other than by the offeree company itself) made to the holders of the Securities of a company to acquire all or some of those Securities, whether mandatory or voluntary, which follows or has as its objective the acquisition of control of the offeree company.
<b>Takeover Principles</b>	Principles prescribed by the AFSA pursuant to section 88(1)(b) of the Framework Regulations.
<b>Takeover Rules</b>	Rules prescribed by the AFSA pursuant to section 88(1)(a) of the Framework Regulations.
<b>Temporary Administrator</b>	A person appointed by the AFSA under section 150 of the FSFR to be a Temporary Administrator of an Authorised Person.
<b>Testing FinTech Activities</b>	The activity as defined in paragraph 2.2.1 of FINTECH
<b>Third Party Account Provider</b>	In relation to a Client Money Account or a Client Investment Account, means an Authorised Firm or Regulated Financial Institution (including a bank, custodian, intermediate broker, settlement agent, clearing house, exchange and/or "over the counter" counterparty) that is a separate legal entity from the Authorised Firm that is required under COB to establish the Client Money Account or Client Investment Account.
<b>Third Party Agent</b>	In relation to a Client Account, means an Authorised Firm or Regulated Financial Institution (including a bank, custodian, an intermediate broker, a settlement agent, a clearing house, an exchange and 'over the counter' counterparty) that is a separate legal entity from the Authorised Firm that is required under COB to establish the Client Account.
<b>Third Party Digital wallet Service Provider</b>	(1) A Digital wallet Service Provider other than a Digital Asset Trading Facility Operator Providing Custody of Digital Assets traded on its facility; or (2) A Person in another jurisdiction Providing Custody of Digital Assets by holding and controlling the public and private cryptographic keys relating to the Digital Assets, which is authorised and appropriately supervised for that activity by a Financial Services Regulator.
<b>Tier 1 Capital</b>	Has the meaning given in BBR 4.13
<b>Tier 1 Capital</b>	The components of capital identified at paragraph 3 (Components of Tier 1 Capital) of PINS Schedule 3 (Calculation of Eligible capital) The components of capital identified at paragraph 3 of TRR Schedule 3 (Calculation of Eligible capital).
<b>Tier 2 Capital</b>	Has the meaning given in BBR 4.18
<b>Tier 2 Capital</b>	The components of capital identified at paragraph 4 (Components of Tier 2 Capital) of PINS Schedule 3 (Calculation of Eligible capital) The components of capital identified at paragraph 4 of TRR Schedule 3 (Calculation of Eligible capital)
<b>Token</b>	A digital representation of value, rights or obligations, which may be issued, transferred and stored electronically, using DLT or other similar technology.



<b>Trade Repository</b>	A centralised registry that maintains an electronic database containing records of transactions in Derivatives, including over-the-counter Derivatives.
<b>Trading Book</b>	Has the meaning given in BBR 6.2
<b>Transaction</b>	Any transaction undertaken by an Authorised Firm in the course of carrying on a Financial Service in or from the AIFC.
<b>Transaction Services for Decentralised Digital Assets</b> (also known as Mining)	Validation and adding transactions made with a Decentralised Digital Assets to the ledger of all transactions.
<b>Travel Rule</b>	Has the meaning given to it in FATF's <i>Updated Guidance for a Risk-Based Approach for Virtual Assets and Virtual Asset Service Providers</i> [October 2021], as may be amended from time to time
<b>Umbrella Fund</b>	A Fund in which the contributions of the Unitholders in the Fund and the profits or income out of which payments made to them are pooled separately in a number of Sub-Funds constituting separate parts of the Fund Property.
<b>Undertaking</b>	(a) a Body Corporate; or (b) Partnership; or (c) an unincorporated association carrying on a trade or business, with or without a view to profit.
<b>Unit</b>	A unit in or a share representing the rights or interests of a Unitholder in a Fund.
<b>Unitholder</b>	A Person who participates in a Fund.
<b>UNSCR</b>	United Nations Security Council Resolutions, as referenced in AML 12.1.
<b>Unsolicited Real Time Financial Promotion</b>	Has the meaning given in COB 3.4.2.
<b>Utility Token</b>	A Digital Asset: (a) which can be used by the holder only to pay for, receive a discount on, or access a product or service (whether current or proposed); and (b) the product or service referred to in (a) is provided by the issuer of the Digital Asset or of another entity in the issuer's Group.
<b>Valuer</b>	A valuer of a Fund's property appointed in accordance with CIS.
<b>Venture Capital Fund</b>	A type of Specialist Fund defined in CIS 2.4(b)(iii).
<b>Warrant</b>	an instrument that confers on the holder a right entitling the holder to acquire an unissued Share or Debenture
<b>Write Down or Conversion Power</b>	The power referred to in section 147(1)(e) of the FSFR.
