### PART 2: FORMATION AND REGISTRATION

#### 12. Registration as General Partnership

(1) On the formation of a general partnership in the AIFC, the partners may apply for registration of the general partnership, and for the registration of each of the partners, by signing, and filing with the Registrar of Companies, an application for registration.

(2) The application must set out:

(...)

(b) the address of the registered office of the general partnership in the AIFC; and

(ba) the registered email address; and

(...)

#### 13. Registration as Recognised Partnership

(1) The partners of a general partnership formed outside of the AIFC may apply for the registration of the partnership as a Recognised Partnership, and for the registration of each of the partners, by signing, and filing with the Registrar of Companies, an application for registration.

(2) The application must set out:

(...)

(b) the address for service of the general partnership in the AIFC, and the name and address of the Person authorised to accept service of any document on behalf of the partnership; and

(ba) the registered email address; and

(...)

#### 14. Notification of change in Registered Details of General or Recognised Partnership

(1) This section applies if there is a change in:

(...)

(c) any other particulars relating to the Registered Details of the General Partnership, Recognised Partnership, or the Person authorised to accept service of any document on behalf of the Recognised Partnership including a change of address for service, or registered email address.

### PART 3: ADMINISTRATION OF AFFAIRS OF PARTNERSHIPS

#### 16-1. Registered email address

(1) A General Partnership must have a registered email address to which all communications and notices to the partnership may be addressed.

(2) A Recognised Partnership must have a registered email address to which all communications and notices to the partnership may be addressed.

(3) A General Partnership may change its registered email address by giving notice to the Registrar. The change takes effect upon the notice being registered by the Registrar.

(4) A Recognised Partnership may change its registered email address by giving notice to the Registrar. The change takes effect upon the notice being registered by the Registrar.

(5) Contravention of this section is punishable by a fine.

### **18. Particulars in partnership communications**

(1) A General Partnership must ensure that its name, ~~and~~ the address of its registered office, and the registered email address appear in legible characters in all of its letterheads, order forms, receipts, correspondence and other communications.

(2) A Recognised Partnership must ensure that, in relation to the business, purpose or activity it conducts in or from the AIFC, its name, ~~and~~ its address for service, and the registered email address appear in legible characters in all of its letterheads, order forms, receipts, correspondence and other communications.

(3) Contravention of this section is punishable by a fine.

#### **39-1. Strike off and Restoration**

The provisions of sections 167 and 168 of the AIFC Companies Regulations apply to a General Partnership and a Recognised General Partnership.
