### **PART 2: FORMATION AND REGISTRATION**

#### **10. Method of formation**

(1) Two or more Persons may apply for the incorporation of a Limited Liability Partnership in accordance with the terms of a partnership agreement, by signing and filing with the Registrar of Companies an application for incorporation in accordance with the Rules.

(2) The application must state the following:

(b) the proposed address of the partnership's registered office;

(ba) the registered email address;

(...)

### **PART 4: CONDUCT OF BUSINESS**

#### **15-1. Limited Liability Partnerships: registered email address**

(1) A Limited Liability Partnership must have a registered email address to which all communications and notices to the partnership may be addressed.

(2) A Limited Liability Partnership may change its registered email address by giving notice to the Registrar. The change takes effect upon the notice being registered by the Registrar.

(3) Contravention of this section is punishable by a fine.

#### **16. Limited Liability Partnerships: particulars in communications**

(1) A Limited Liability Partnership must ensure that its name, ~~and~~ the address of its registered office, and the registered email address appear in legible characters in all of its instruments, invoices, letterheads, order forms, receipts, statements of account, correspondence, publications and other communications, including any communications in electronic form.

### **PART 8: RECOGNISED LIMITED LIABILITY PARTNERSHIPS**

#### **37. Requirements applying to Recognised Limited Liability Partnerships**

A Recognised Limited Liability Partnership must:

(...)

(b) have at all times a principal place of business in the AIFC to which all communications and notices may be addressed; and

(ba) have the registered email address

(c) file with the Registrar of Companies, in accordance with the Rules, notice of the following:

(...)

(iv) any change in the constitution of the partnership, by the incoming or outgoing of any member.

(v) the registered email address.

### **37-1. Recognised Limited Liability Partnerships: registered email address**

(1) A Recognised Limited Liability Partnership must have a registered email address to which all communications and notices to the partnership may be addressed.

(2) A Recognised Limited Liability Partnership may change its registered email address by giving notice to the Registrar. The change takes effect upon the notice being registered by the Registrar.

(3) Contravention of this section is punishable by a fine.

### **39. Recognised Limited Partnerships: particulars in communications**

(1) A Recognised Limited Liability Partnership must ensure that, in relation to the business, purpose or activity it conducts in or from the AIFC, its name, ~~and~~ its address for service, and the registered email address appear in legible characters in all of its instruments, invoices, letterheads, order forms, receipts, statements of account, correspondence, publications and other communications, including any communications in electronic form.

#### **49-1. Strike off and Restoration**

The provisions of sections 167 and 168 of the AIFC Companies Regulations apply to a Limited Liability Partnership and a Recognised Limited Liability Partnership.
