



A Step-by-Step Guide to Investment Tax Residency Programme

Step 1. Select a Legitimate Authorised Agent

Applicant is required to select an Authorised Agent to assist with their application. Only Authorised Agents are mandated to represent the applicant when submitting the application.

Step 2. Submit your application

Submit an online application with payment of the application processing fee:

- main applicant only - USD 7,750 excl. VAT;
- main applicant + (1) spouse - USD 11,375 excl. VAT.



Step 3. Due diligence checks

Undergo a thorough background check of the main applicant and applicable dependents included in the application.



Step 4. Complete the investment

Invest no less than the minimum required investment volume in the approved instrument.

This includes securities traded on the Astana International Exchange, investments in the share capital of companies established in the AIFC, and digital assets traded on platforms operated by digital asset service providers licensed by the Astana Financial Services Authority (AFSA).



Step 5. Receive approval

Become the AIFC Investment Resident which grants the main applicant and his family a long-term visa.

Applicants who wish to become a Tax Resident of Kazakhstan shall apply further to the authorized state body with applicable annual fees (7,000 MCI*).

Applicants have to comply with the “90-day residency rule”.

*1 MCI = KZT 4,325 in 2026
